Lifeline, Inc. Seeking Volunteers to Assist with Income Tax Assistance Program October 19, 2020

PAINESVILLE, Ohio— Lifeline, Inc., Lake & Geauga Counties Community Action Agency, is currently seeking volunteers to fill the roles of greeter/intake, scheduler, certified tax preparer and site coordinator in order to assist low to moderate income households with tax preparation for the 2021 tax season. This program is offered in partnership with the Internal Revenue Service (IRS) office in Cleveland, Ohio.

Lifeline, Inc. will provide free tax preparation to qualifying Lake & Geauga County residents beginning in mid-January and continuing through April of 2021 as part of the IRS developed Volunteer Income Tax Assistance Program (VITA). The program trains volunteers to prepare federal and state tax returns for working families, elderly, and individuals with disabilities. All tax clinics will be offered in compliance with CDC and local COVID-19 guidelines and all volunteers will be equipped with necessary safety protocols.

Anyone can volunteer. No previous tax experience is necessary, only a desire to help others in need. Volunteers participate in several training levels. Once certified, volunteers will be scheduled to assist with tax preparation January through April. Lifeline, Inc. will use computers to electronically prepare and transmit tax returns.

You can make a real difference in the lives of working families by helping them remain compliant with IRS regulations and filings and allowing them to take advantage of every tax benefit to which they are entitled. Because this program files tax returns electronically, it allows for fast refunds to the taxpayer. This service also affords that tax dollars due the federal, state, and local governments are received by those governments in order to maintain and protect your communities.

Lifeline's current programming includes services in the healthcare, housing & energy assistance, information & referral services and consumer education & job training areas. Our motto is 'helping people, changing lives.' Lifeline is currently funded by the UWLC and by grants through the ODSA, the Lake County Board of Commissioners, the Lake County ADAMHS Board, Lake County Department of Job & Family Services, the City of Mentor, the Western Reserve Junior Service League, the Lake County Board of Developmental Disabilities, Lake Health and through private donors.
